## Rental Rates

### **Package A: Sensory Room Equipment with Autism Edmonton Staff (items to fill the space provided)**

- \$350 per day /8 hours maximum for non-profit
- \$550 per day/8 hours maximum for business/gov't

### **Package B: Sensory Room Equipment without Autism Edmonton Staff (items to fill the space provided)**

- \$200 per day for non-profit
- \$300 per day for business

### **Package C: Sensory Corner (12 items including beanbag chair)**

- \$100 per day for nonprofit
- \$150 per day for business/gov't

**A \$500 refundable deposit is required for all rental packages.**
